Gallery Rules and Guidelines

The Arts Council of Livingston Parish is inviting all students, ages 6 – 18 in Livingston Parish to submit art for exhibit at the gallery March 6th – April 20th 2024.

Guidelines:

PLEASE READ, CHECK SPACES, TO CONFIRM. SIGN AND SUBMIT THIS FORM ALONG WITH LABELS FOR YOUR ARTWORK WHEN YOU DELIVER YOUR ARTWORK TO THE GALLERY. KEEP A COPY FOR YOUR RECORDS.

___ Young artist's ages 6 – 18 residing in Livingston Parish are eligible.

___ Artwork must be original work completed by student only.

___ Subject matter must be suitable for family viewing. No portrayal of blood, violence or nudity will be allowed to hang.

___ Two dimensional media will be accepted. Art must have a wire connected to eyehooks for hanging. No saw tooth hangers will be allowed because they are not compatible with our hanging system. Any student needing assistance in preparing their artwork for hanging, please contact the gallery. Maximum size is 24"x36". All media will be accepted. Work may be on canvas with a wire. Canvas should not have staples on the sides. Works on paper must be framed with a wire.

___ Three-dimensional work will be considered and may be allowed by special arrangements made with the Arts Council of Livingston Parish Gallery Committee.

___ Works must be identified on the piece itself. Labels giving name, address, phone number, title of painting or work, and price if for sale must be secured to the back of the frame.

___ If the exhibiting student artist would like to sell their work, please provide price of art and other items in the exhibit.

___ The Arts Council of Livingston Parish will do its best to protect artwork and other items from theft or damage. However, all liability and insurance for work left on display is the sole responsibility of the artist.

____The Arts Council of Livingston Parish will not retain a commission of sales for student work.

____Press release statement: The artist gives permission to the Arts Council of Livingston Parish and any agency or website affiliated with ACLP to photograph exhibit and art for publicity purposes only.

I have read and agree to all requirements and will abide by all of the above. I hereby release the Arts Council of Livingston Parish from any legal liability regarding the exhibit of my work.

ARTWORK DROP-OFF IS FEBRUARY 28 - MARCH 2, 2024 DURING GALLERY HOURS. ARTWORK PICK UP IS APRIL 24-27, 2024 DURING GALLERY HOURS. GALLERY IS OPEN WEDNESDAY THROUGH FRIDAY FROM 10 AM – 12 PM AND SATURDAY FROM 10 AM – 2 PM.
